RETURNING ATTENDEES

If you have registered and attended L.A. Textile in the past two years, you will receive an EXPRESS PASS via e-mail with EXPRESS CHECK-IN instructions. If you are not a CMC e-mail subscriber, simply present your business card and photo identification at any Registration counter. †**Guest Fee will be charged to any person not presenting these credentials.**

NEW ATTENDEES

If you are a ***qualified industry professional mentioned above** and have never registered and attended L.A. Textile (or haven't done so in the past two years), present the following 4 items at a Registration counter: 1) Registration Form 2) your business card printed in your name & your company's name; 3) your photo identification; 4) and any one of the following:

- Photocopy of Business License
- Photocopy of State Sales & Use Tax Certificate or Federal EIN Certificate
- Photocopy of three current industry-related invoices
- Photocopy of Yellow Pages ad, business ad or store lease
- Manufacturers: Copy of brochure for products you manufacture

PRESS

All members of the press are required to check-in on arrival in the Buyers Lounge, Suite B271 (2nd floor, B-wing). Contact press@californiamarketcenter.com to pre-register and include: your name, title, media outlet and complete contact information or register on-site in the Buyers Lounge by presenting your business card and photo identification. Freelance journalists may substitute a card with either an editorial credit/byline or published masthead.

†GUEST POLICY

Visitors not presenting the credentials mentioned above are considered Guests and are subject to a **\$20 non-refundable fee**. Spouses and children under 12 are an exception. Guests must be accompanied by a registered Buyer with badge. Visit the Registration counter for a Visitor badge.

CHILDREN
