Admittance to the event is open to qualified Fabric Buyers related to fashion/gift/interior design, fashion/gift/interior product manufacturing, fabric & trim retailers, and Press only.

WHAT TYPE OF BUSINESS QUALIFIES YOU AS A FABRIC BUYER?

- Apparel Manufacturer / Designer
- Home Furnishings Manufacturer / Designer
- Accessories Manufacturer / Designer
- U.S.-Based Exporter - Fabric/Trim
- Fabric & Trim Retailer

CREDENTIALS REQUIRED FOR REGISTRATION AS A NEW BUYER

If you are a Fabric Buyer who has not registered for the LA Int'l Textile Show within the past two years, the following must be presented at Registration to qualify you for admittance:

1. Business Card printed with your name and company
2. Photo I.D. (Driver's License, Passport, etc.)
3. Two (2) of the following:
 - Business License
 - Photocopy of State Sales & Use Tax Certificate or Federal EIN Certificate
 - Photocopy of three (3) current industry-related invoices
 - Photocopy of Yellow Pages ad, business ad or store lease
 - Manufacturers: Copy of brochure for products you manufacture

Each additional attendee for your company will need to present:

1. Photo I.D.
2. One (1) of the following:
 - Personalized Business Card
 - Payroll Stub
 - Company Credit Card in attendee's name

RETURNING BUYERS

Returning Buyers are pre-qualified Fabric Buyers who have registered for the LA Int'l Textile Show within the past two years.
